Stated Clerk and Interim Mission Coordinator Report

Presbytery Office Move

The Presbytery Office will be moving to the office suite next door to us. The move will happen later this summer and an announcement will go out once the move has occurred. The move will reduce our office space to a more appropriate size for our operations and save the Presbytery \$3,600 a year.

Clerk of Session Trainings

I will be offering two more training / networking workshops for Clerks of Session. More details will follow as the dates get closer. The dates and locations are:

October 28, 2017 – Sioux Falls November 18, 2017 – Pierre

Presbytery of SD Membership

Total membership of active members, based on 2016 statistics, within the Presbytery of South Dakota is 6,297. We gained 276 members, lost 282 to death or certificate transfer, and 288 listed as "other" losses. The "other" category is traditionally used for churches cleaning their rolls. With that in mind, the difference in actual membership may more accurately be presented as 6 true losses in 2016.

Minister Transactions

The following minister transactions have been completed and are registered with the Office of General Assembly: Dave Ullom to Prospect Hill. Jack Whetzel passed away and has been removed from our rolls.

Synod Minutes Review

I attended the annual synod minutes review for all of the stated clerks within the Synod of Lakes and Prairies. The minutes of the Presbytery of SD have been approved with 2 exceptions, which have been corrected.

ADMINSTRATION AND COORDINATION MINISTRY

The following actions of A&C Ministry are taken from the minutes of April 7 and June 2. 2017 minutes

Actions taken on behalf of the Presbytery

Vetal Church sale

The \$1000 received from sale of the Vetal Church property was placed in the Church Development/Redevelopment Fund.

Per Capita Apportionments

The Stated Clerk was given permission to report late adjustments to reported memberships within memberships that impact their per capita apportionments.

Office Lease

The Presbytery office will be moving to a space next to the current office at a savings of \$3,600 per year. Rent will be \$700 a month for a two (2) year lease.

Two Member Teams

A motion was made that as congregations request assistance from the Presbytery with their ongoing life and mission, or a ministry of the Presbytery deems necessary, it will be our policy to send two or more representatives.

For Presbytery's Information

A motion that all monies invested in CD's with various banks will, as they mature, be invested in our New Covenant Fund within the Presbyterian Foundation. Members of the Budget and Finance subcommittee, in consultation with our representative from the Foundation, will decide how those funds are invested.

A motion to add Deb VanOvershelde, with authority to transfer, and Kevin Veldhuisen, without authority to transfer, to all bank accounts. In addition, Ruth Perry and Evelyn Reynen will be removed from all accounts.

A motion to change recommended percentages of allocated mission money for Presbytery, Synod and GA. Change for Presbytery is from 60% to 80%, Synod from 23% to 13% and GA from 17% to 7%. This offers an annual increase in Presbytery mission income of approximately \$34,666.

For Presbytery Action

A motion was made to increase the membership of the Permanent Judicial Commission from eight (8) members to nine (9) members in order to adhere to General Assembly recommendations. This will make a change to the Manual of Operations.

A motion to amend the By-Laws that each Ministry may, at their option, elect a vice-moderator.

A motion to approve the job description for the Presbytery Administrative Assistant position. Appendix A

At this time Stated Clerk Kevin Veldhuisen was asked to leave the room and Rev. Don Barbalace was named stated clerk pro tem.

A motion to hire Kevin Veldhuisen as Mission Coordinator, after lengthy discussion, was **tabled until the October 27, 2017 meeting of presbytery.**

At this time Kevin Veldhuisen returned and assumed his responsibilities as stated clerk.

CONGREGATIONAL AND PASTORAL CARE MINISTRY TEAM

Actions taken on behalf of the Presbytery

CPC approved the reception of The Rev. Peter Reynen as a Member-at-large.

CPC approved John Pehrson as representative to the Board of Pensions' consultation in May 2017. Expenses to be paid from Bicentennial Fund.

CPC approved Interim Pastor Covenant Agreement between the Board of Trustees of the United Churches of Hot Springs. SD and the Rev. Dr. John Pehrson. Terms:

- May 1, 2017 October 31. 2017, renewable for up to 5 1/2 months.
- Cash Salary: \$8,400
- Housing: (Free use of parsonage as necessary for overnight lodging)
- Vacation: 10 days, including 4 Sundays
- Automobile reimbursement at IRS rate (currently \$0.35) including commuter mileage from Rapid City.
- Part-time position, 20 hours weekly.

CPC approved Session of First Presbyterian, Onida, to call a meeting of the congregation, April 2, 2017, to act on dissolution of the pastoral relationship with The Rev. Roland Kemink, effective June 30, 2017. The Rev. Roland Kemink is retiring June 30, 2017. The session is granted permission to allow the congregation to elect a PNC.

Administrative Commission for First Presbyterian Church, Aberdeen, has been granted permission to call a meeting of the congregation to elect a PNC. The PNC will include five (5) members of the congregation, plus two (2) advisory members from the commission.

CPC appointed The Rev. John Armstrong, to be moderator of Onida, beginning July 1, 2017.

CPC appointed The Rev. Dr. David Halleen, to be moderator of Westminster Presbyterian Church, Sioux Falls, effective immediately.

CPC approved RE Ember Dady and RE Cheryl Jenner, to serve communion in the Sisseton/Veblen congregations.

CPC appointed TE Val Putnam and Wes Putnam to conduct exit interviews with session of Spencer Memorial, Lemmon, and with Ed Timmerman.

CPC appointed TE Dick Poppen, moderator for Endeavor Presbyterian, Fedora.

CPC approved the Call of First Presbyterian, Brookings, to The Rev. Nina Lashari Westfall, along with the terms. CPC voted to receive her as member of Presbytery of South Dakota, pending her transfer from Boise Presbytery. She will begin September 1, 2017. Terms of Call: Effective Cash Salary, salary and housing - \$46,000; Car Allowance (vouchered at IRS rate) – up to \$2500; Professional expense (vouchered) – up to \$1250; Study Leave – up to \$1500; Full pension benefits; ½ Self-Employment Tax; 2 weeks study leave; 4 weeks personal vacation; moving expenses (vouchered) up to \$3000, additional expense negotiable.

CPC approved following Ruling Elders of Wildflower Presbyterian to celebrate sacrament of Lord's Supper: Joe Van Holland, Diane Anderson, Larry Anderson, Mary Lambert. The Rev. Don Barbalace provided the training.

CPC approved the MIF for Hot Springs United Church. PNC will now upload MIF into CLC and begin processing candidates for church.

CPC approved receiving the Rev. Everett Bosch, Honorably Retired, as member of Presbytery, pending receipt of papers from Stockton Presbytery. He and his wife currently attend First Presbyterian, Sioux Falls.

CPC approved the transfer of The Rev. David Ullom, to Prospect Hills Presbytery. Dave has received a call to serve as pastor of First Presbyterian Church, Estherville, Iowa, beginning July 1, 2017.

CPC approved the Pulpit Supply List developed by Shari. It will be inserted in Directory.

For Presbytery's Information

CPC is now responsible for Session Minutes/Records review of member churches. RE Shari West-Twitero, CPC and RE Brenda Tibbets, Westminster, Sioux Falls, will provide leadership for this task.

Moderator reported letter The Rev. Denzel Nonhof sent to Session of First Presbyterian, Sturgis, announcing his retirement, January 15, 2019. John Pehrson and Shari West-Twitero will arrange meeting with Session to discuss transition issues. Denzel has stated intention to remain in Sturgis area following retirement.

Meleta DeJong and Lori Robinson reported exit interviews for Session of Onida Presbyterian and with The Rev. Rolly Kemink. The Rev. John Armstrong will begin as Moderator, July 1st. Transition proceeding smoothly. PNC working on preparation of MIF.

Kevin Veldhuisen reported on need to review Presbytery need for Boundary/Sexual Misconduct/ Harassment training, to comply with denomination requirements and insurance liabilities. CPC approved plan to present this need to June meeting of Presbytery and inform commissioners that a plan of action will be presented at October meeting of Presbytery.

APPENDIX A

PRESBYTERY ADMINISTRATIVE ASSISTANT POSITION DESCRIPTION (June 23, 2017)

A. TITLE:

Administrative Assistant (28 hours per week, non-exempt)

B. PURPOSE:

To provide secretarial and administrative services to the Presbytery officers and staff, Presbytery A&C, ministries, and task forces as needed.

C. ACCOUNTABILITY:

The administrative assistant is accountable to the Mission Coordinator and Personnel Sub-Committee of Administration and Coordination.

D. RESPONSIBILITIES:

- 1. Manage the work of the office seeing to the workflow, the scheduling of meetings, and the use of the office and conference rooms.
- 2. Receive visitors and provide a listening ear for people of the presbytery.
- 3. Sort mail daily, tracking and responding to pieces requiring immediate attention.
- 4. Maintain files of the presbytery.
- 5. Work with Communication Subcommittee and staff to maintain calendar and website.
- 6. Oversee the purchase of office supplies.
- 7. Notify Presbytery members, A&C and ministry committee members of meetings, conference calls, etc.
- 8. Copy and distribute materials as requested.
- 9. Prepare reports, as needed for A&C and Presbytery meetings.
- 10. Prepare directories for Presbytery A&C, Presbytery ministries, pastors and churches.
- 11. Order meals for all meetings scheduled at the Presbytery office, as requested.
- 12. Maintain computer address list for mailings.
- 13. Deposit checks.
- 14. Help auditors as necessary.
- 15. Scan deposit information and e-mail to treasurer.
- 16. Scan approved vouchers and bills and e-mail to treasurer.
- 17. Prepare materials for registration and serve as Presbytery registrar at Presbytery meetings.
- 18. Other duties as needed and as time allows.
