- 6. Call forms are referred to Committee on Ministry of pastor-elect's presbytery for recommendation to presbytery.
- 7 Upon approval:
 - a. Present one call form to pastor-elect
 - b. Send two copies to presbytery of call
 - c. Retain one copy for presbytery files
- 8. Stated Clerk in presbytery of call shall:
 - a. Forward one copy to clerk of session of calling congregation
 - b. Retain one copy for presbytery files
- 9. Final distribution shall then be:
 - a. Pastor-elect (one copy)
 - b. Presbytery of membership (one copy)
 - c. Presbytery of call (one copy)
 - d. Congregation of call (one copy)
